

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2020 San Xavier District Budget)**

**RESOLUTION NO. 19-356**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

12 **WHEREAS,** by San Xavier District Council Resolution No. SXDC 08-19-12, the San Xavier  
13 District has authorized the FY 2020 San Xavier District Budget, which is  
14 incorporated by this reference, in the amount of \$10,281,911.53; and

15 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2020 San Xavier District  
16 Budget and recommends its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
18 FY 2020 San Xavier District Budget in the amount of \$10,281,911.53 that includes  
19 funding from:

- 20 1. FY 2020 San Xavier District Gaming Allocation funds in the amount of  
21 \$6,220,870.86;
- 22 2. ASARCO Mine Lease Rental-Office of Special Trustee funds in the amount  
23 of \$7,624.33;
- 24 3. Grant funds in the amount of \$851,279.96;
- 25 4. 9B Farm Cash Out funds in the amount of \$1,483,105.06;
- 26 5. Reserve Investment Account funds in the amount of \$515,871.20;
- 27 6. Employee Benefit Trust Account funds in the amount of \$118,746.29; and
- 28 7. Bond Investment Account funds in the amount of \$1,084,413.83.

29 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2020 San  
30 Xavier District Budget shall be managed and expended in accordance with Article  
31 IX, Section 7, of the Constitution of the Tohono O'odham Nation and the Nation's  
32 laws, provided that any amendments or modifications shall be authorized under  
33 District Council resolution and submitted for prior approval by the Tohono  
34 O'odham Legislative Council.

1 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup>  
2 day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-  
3 AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by  
4 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
5 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
6 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934  
7 (48 Stat.984).


