

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 San Lucy District Budget)**

RESOLUTION NO. 19-357

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** by San Lucy District Council Resolution No. SL 08-205-19, the San Lucy District has
13 authorized the FY 2020 San Lucy District Budget, which is incorporated by this
14 reference, in the amount of \$11,864,798.39; and

15 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2020 San Lucy District
16 Budget and recommends its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 FY 2020 San Lucy District Budget in the amount of \$11,864,798.39, which includes
19 funding from:

- 20 1. FY 2020 district gaming allocation in the amount of \$7,740,203.01; and
- 21 2. FY 2015, FY 2016, FY 2017, FY 2018 carry over funds and partial FY 2019
22 carry over funds in the amount of \$4,124,595.38.

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2020 San Lucy
24 District Budget shall be managed and expended in accordance with Article IX,
25 Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws,
26 provided that any amendments or modifications shall be authorized under
27 District Council resolution and submitted for prior approval by the Tohono
28 O'odham Legislative Council.

29 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND
30 day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-
31 AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by
32 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
33 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
34 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
