

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Chukut Kuk District West Villages Community Budget
Amendment No. 1)**

RESOLUTION NO. 20-024

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2020 Chukut Kuk District Budget in the amount of \$2,129,448.90 was
13 authorized by Chukut Kuk District Council Resolution No. 2019-39 and approved
14 by Legislative Council Resolution No. 19-352 and subsequently amended by
15 Chukut Kuk District Council Resolution No. 2019-45 and approved by Legislative
16 Council Resolution No. 19-461 in the amount of \$2,405,912.32; and

17 **WHEREAS,** by Chukut Kuk District Resolution No. 2019-51, the Chukut Kuk District has
18 prepared and submitted for review and approval its FY 2020 West Villages
19 Community Budget Amendment No. 1, which is incorporated by this reference
20 and which will adjust operational/personnel line items; and

21 **WHEREAS,** the FY 2020 West Villages Community Budget Amendment No. 1 will increase the
22 FY 2020 West Villages Community Budget by \$27,855.70 from \$40,000.00 to
23 \$67,855.70 and will also increase the FY 2020 Chukut Kuk District Budget from
24 \$2,405,912.32 to \$2,433,768.02; and

25 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2020 Chukut Kuk District
26 West Villages Budget Amendment No. 1 and recommends its approval.

27 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
28 FY 2020 Chukut Kuk District West Villages Budget Amendment No. 1, which
29 includes a \$27,855.70 increase from \$40,000.00 to \$67,855.70 and increases the FY
30 2020 Chukut Kuk District Budget from \$2,405,912.32 to \$2,433,768.02 that shall be
31 funded as follows:

- 32 1. FY 2017 Surplus Funds in the amount of \$5,068.37
- 33 2. FY 2018 Surplus Funds in the amount of \$3,292.85
- 34 3. FY 2019 Surplus Funds in the amount of \$9,571.15

1 4. FY 2014 Mining Allocation in the amount of \$4,975.78

2 5. FY 2016 Mining Allocation in the amount of \$4,947.55.


3 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2020 Chukut
4 Kuk District West Villages Community Budget as amended shall be managed and
5 expended in accordance with Article IX, Section 7 of the Constitution of the
6 Tohono O'odham Nation and the Nation's laws, provided that any amendments or
7 modifications shall be authorized under District Council resolution and
8 submitted for prior approval by the Tohono O'odham Legislative Council.

9 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH
10 day of JANUARY, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-
11 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
12 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
13 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
14 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
15 (48 Stat.984).


