

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Accounts Receivable Write-off for the Former Hia-Ced District)**

RESOLUTION NO. 20-025

1 **WHEREAS, the Legislative Council created the Hia-Ced District of the Tohono O'odham**
2 **Nation by Resolution No. 12-423; and**

3 **WHEREAS, on April 25, 2015, the Hia-Ced District was dissolved by the Tohono O'odham**
4 **Nation's voters through Initiative INT-01-14, Dissolution of the Hia-Ced District;**
5 **and**

6 **WHEREAS, by Legislative Council Resolution No. 15-158, election results for Initiative INT-01-**
7 **14, "Dissolution of the Hia-Ced District" were certified; and**

8 **WHEREAS, at the time of the dissolution, the former Hia-Ced District did have an accounts**
9 **receivable balance due to the Nation in the amount of \$13,939.93; and**

10 **WHEREAS, the Nation's Accounting Office recommends a write-off of the accounts receivable**
11 **balance; and**

12 **WHEREAS, the Nation's Executive Office and the Budget and Finance Committee have**
13 **reviewed the accounts receivable write-off and recommends its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council approves**
15 **the accounts receivable balance write-off in the amount of \$13,939.93 for the**
16 **former Hia-Ced District.**

17 **BE IT FURTHER RESOLVED THAT the Tohono O'odham Legislative Council authorizes the**
18 **Nation's Accounting Office to write-off the accounts receivable balance in the**
19 **amount of \$13,939.93 for the former Hia-Ced District.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH**
21 **day of JANUARY, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
23 **Article VI, Section 1(d) of the Constitution of the Tohono O'odham Nation, adopted by the**
24 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat.984).**
