

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 19-342 to Correct Budget Amount)**

RESOLUTION NO. 20-032

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2020 Planning and Economic Development Department Roads Program**
8 **Project PIR 21(4) Santa Cruz to Papago Farms Budget in the amount of**
9 **\$8,444,000.00 was approved by Legislative Council Resolution No. 19-342; and**

10 **WHEREAS, the FY 2020 budget amount in the second whereas and resolved clauses of**
11 **Resolution No. 19-342 incorrectly state the amount as \$8,444,000.00 instead of the**
12 **correct amount, \$8,440,000.00; and**

13 **WHEREAS, the Budget and Finance Committee has reviewed the proposed amendment to**
14 **Resolution No. 19-342 to correct the FY 2020 Planning and Economic**
15 **Development Department Roads Program Project PIR 21(4) Santa Cruz to Papago**
16 **Farms Budget amount from \$8,444,000.00 to \$8,440,000.00 and recommends its**
17 **approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council amends the**
19 **second whereas and first resolved clauses of Resolution No. 19-342 as follows:**

21 **WHEREAS, the Planning and Economic Development Department has prepared**
22 **and submitted for review and approval its FY 2020 Roads Program Project PIR**
23 **21(4) Santa Cruz to Papago Farms Budget, which is incorporated by this reference,**
24 **in the amount of \$8,444,000.00\$8,440,000.00 to be funded from the Nation's**
25 **general fund pending reimbursement from the Bureau of Indian Affairs; and**

27 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**
28 **approves the FY 2020 Planning and Economic Development Department Roads**
29 **Program Project PIR21(4) Santa Cruz to Papago Farms Budget effective October**
30 **1, 2019 in the amount of \$8,444,000.00\$8,440,000.00, which shall be funded by the**
31 **Nation's general fund pending reimbursement from the Bureau of Indian Affairs.**

2 day of JANUARY, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-
3 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
4 Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the
5 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
6 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
7 18, 1934 (48 Stat.984).
