(Amending Enrollment Resolution Nos. 02-332, 02-508, 03-003, 03-280, 04-109, 05-472,
and 07-236 to Correct Names of Enrolled Members and/or Enrollment Numbers)

RESOLUTION NO. 20-037

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article II,**
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications and**
7 **making recommendations to the Legislative Council regarding the eligibility of**
8 **applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

9 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**
10 **O'odham Legislative Council shall determine whether an application is approved**
11 **for membership and its determination, along with the resolution number and**
12 **date of enactment, shall be provided to the applicant; and**

13 **WHEREAS, the Enrollment Program has determined that a number of resolutions approving**
14 **membership and adoption applications misspelled or incorrectly listed the**
15 **names of members and/or incorrectly listed enrollment numbers; and**

16 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 02-332, 02-**
17 **508, 03-003, 03-280, 04-109, 05-472, and 07-236 be amended to reflect the correct**
18 **name and/or enrollment number for the members identified in the February**
19 **2020 Corrected Enrollment Resolution Summary, which is incorporated by this**
20 **reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
22 **Nos. 02-332, 02-508, 03-003, 03-280, 04-109, 05-472, and 07-236 are amended upon**
23 **the effective date of those resolutions to reflect the correct name and/or**
24 **enrollment number for the members identified in the February 2020 Corrected**
25 **Enrollment Resolution Summary.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
27 **day of FEBRUARY, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
28 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
29 **Article II, Section 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**
30 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
31 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
32 **16 of the Act of June 18, 1934 (48 Stat.984).**
