

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Department of Health and Human Services Division of Child
Welfare Title IV-B Subpart One and Subpart Two Budget Amendments No. 1)**

RESOLUTION NO. 20-046

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2020 Department of Health and Human Services Division of Child Welfare**
8 **Title IV-B Subpart One Budget in the amount of \$84,163.77 and Subpart Two**
9 **Budget in the amount of \$203,344.79 were approved by Resolution No. 19-326; and**

10 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
11 **review and approval its FY 2020 Division of Child Welfare Title IV-B Subpart One**
12 **and Subpart Two Budget Amendments No. 1, which are incorporated by this**
13 **reference and which will adjust operational and/or personnel line items; and**

14 **WHEREAS, the FY 2020 Department of Health and Human Services Division of Child Welfare**
15 **Title IV-B Subpart One Budget Amendment No. 1 will increase the FY 2020**
16 **Division of Child Welfare Title IV-B Subpart One Budget by \$48,733.23 from**
17 **\$84,163.77 to \$132,897.00; and**

18 **WHEREAS, the FY 2020 Department of Health and Human Services Division of Child Welfare**
19 **Title IV-B Subpart Two Budget Amendment No. 1 will decrease the FY 2020**
20 **Division of Child Welfare Title IV-B Subpart Two Budget amount by \$10,440.79**
21 **from \$203,344.79 to \$192,904.00 and waives indirect costs; and**

22 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
23 **reviewed the FY 2020 Department of Health and Human Services Division of Child**
24 **Welfare Title IV-B Subpart One and Subpart Two Budget Amendments No. 1 and**
25 **recommend their approval.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
27 **FY 2020 Department of Health and Human Services Division of Child Welfare Title**
28 **IV-B Subpart One and Subpart Two Budget Amendments No. 1, effective October**
29 **1, 2019 and which shall be funded by the Nation's general fund pending**
30 **reimbursement from the grantor, DHHS Administration for Children and**




BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation chairperson or any designated official is authorized to administer and expend the FY 2020 Department of Health and Human Services Division of Child Welfare Title IV-B Subpart One and Subpart Two Budgets as amended, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH day of FEBRUARY, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


