

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Reaffirming Resolution No. 19-442 and Nominating Representative Evelyn Juan Manuel as
alternate to Representative Daniel L.A. Preston, III on the Secretary's Tribal Advisory
Committee)**

RESOLUTION NO. 20-055

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the authority to "promote, protect and provide for public health, peace, morals,**
3 **education and general welfare of the Tohono O'odham Nation and its members"**
4 **and to "consult, negotiate and conclude agreements and contracts on behalf of**
5 **the Tohono O'odham Nation with Federal, State and local governments and other**
6 **Indian tribes . . . within the authority of the Tohono O'odham Council."**
7 **(Constitution, Article VI, Section 1(c)(2) and Section 1(f)); and**

8 **WHEREAS, the U.S. Department of Health and Human Services ("HHS") Secretary's Tribal**
9 **Advisory Committee ("STAC") was established in 2010 representing the highest**
10 **level tribal advisory committee in the HHS and is intended as a forum for**
11 **government-to-government consultation; and**

12 **WHEREAS, the STAC's primary purpose is to identify issues and priorities, seek consensus,**
13 **exchange views, share information, provide advice and recommendations, and**
14 **coordinate with HHS agencies on all matters related to improving health and**
15 **human services and ensuring tribal consultation on HHS policies affecting**
16 **American Indian and Alaska Native ("AI/AN") communities (STAC Charter); and**

17 **WHEREAS, the STAC's tribal representation is comprised of seventeen positions to be filled**
18 **by voluntary representatives: one delegate (and one alternate) from each of the**
19 **twelve Indian Health Service ("IHS") areas and one delegate (and one alternate)**
20 **for five National At-Large Tribal Member positions; and**

21 **WHEREAS, by Resolution No. 19-442, the Legislative Council nominated Representative**
22 **Daniel L.A. Preston, III for appointment as the Tucson Area delegate on the**
23 **Secretary's Tribal Advisory Committee but did not nominate an alternate to**
24 **Representative Daniel L.A. Preston, III; and**

25 **WHEREAS, the Health and Human Services Committee recommends nominating**
26 **Representative Evelyn Juan Manuel for appointment as alternate to**
27 **Representative Daniel L.A. Preston, III. on the Secretary's Tribal Advisory**
28 **Committee.**

29 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council reaffirms**
30 **Resolution No. 19-442, "Nominating Representative Daniel L.A. Preston, III to the**
31 **Department of Health and Human Services Secretary's Tribal Advisory**
32 **Committee," and nominates Representative Evelyn Juan Manuel for appointment**
33 **as alternate to Representative Daniel L.A. Preston, III.**




1 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that any appointment
2 made pursuant to this resolution shall immediately expire if the appointed
3 representative no longer serves on the Health and Human Services Committee for
4 any reason.

5 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH
6 day of FEBRUARY, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;
7 -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
8 Article VI, Section 1(c)(2), and Section 1(f) of the Constitution of the Tohono O'odham Nation,
9 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
10 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
11 Act of June 18, 1934 (48 Stat.984).




