

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Department of Education Child Care &
Development-Discretionary Budget Amendment No. 1)

RESOLUTION NO. 20-058

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2020 Department of Education Child Care & Development - Discretionary
8 Budget in the amount of \$2,924,425.00 was approved by Resolution No. 19-312;
9 and

10 **WHEREAS,** the Department of Education has prepared and submitted for review and
11 approval its FY 2020 Child Care & Development - Discretionary Budget
12 Amendment No. 1, which is incorporated by this reference and which will adjust
13 operational and/or personnel line items; and

14 **WHEREAS,** the FY 2020 Department of Education Child Care & Development - Discretionary
15 Budget Amendment No. 1 will not change the budget amount of \$2,924,425.00; and

16 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have
17 reviewed the FY 2020 Department of Education Care & Development -
18 Discretionary Budget Amendment No. 1 and recommend its approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
20 FY 2020 Department of Education Child Care and Development Discretionary
21 Budget Amendment No. 1 effective October 1, 2019, which includes adjustments
22 to the operational and/or personnel line items and will not change the original
23 budget amount of \$2,924,425.00.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend the FY 2020 Department of Education Child Care & Development -
27 Discretionary Budget as amended, provided that any amendments or
28 modifications shall be submitted for prior approval by the Tohono O'odham
29 Legislative Council.
