2 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
3 **and ordinances governing the enrollment and adoption of members (Article VI,**
4 **Section 1 (h) of the Constitution of the Tohono O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications and**
7 **making recommendations to the Legislative Council regarding the eligibility of**
8 **applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

9 **WHEREAS, the Enrollment Program has determined that members were originally approved**
10 **for membership by Resolution Nos. 2000-343, 02-508 and 04-109; and**

11 **WHEREAS, the Enrollment Program discovered that these same members were mistakenly**
12 **approved a second time for membership by Resolution Nos. 03-003, 07-657 and**
13 **09-434; and**

14 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 03-003, 07-**
15 **657 and 09-434 be amended to delete the members identified in the attached**
16 **Amending Enrollment Resolution List for March 2020; and**

17 **WHEREAS, the members that were originally approved in Resolution Nos. 2000-343, 02-508**
18 **and 04-109 will retain the roll number and approval date identified in that**
19 **resolution.**

20 **NOW THEREFORE BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
21 **Nos. 03-003, 07-657 and 09-434, "Approving Enrollment or Adoption Applications**
22 **for Membership in the Tohono O'odham Nation for January 2003, October 2007**
23 **and August 2009" are amended upon effective date of that resolution by deleting**
24 **the members and corresponding information identified in the attached**
25 **Amending Enrollment Resolution List for March 2020.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND**
27 **day of MARCH, 2020 at a meeting at which a quorum was present with a vote of 3,175.7 FOR;**
28 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
29 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**
30 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
31 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
32 **16 of the Act of June 18, 1934 (48 Stat.984).**
