

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Setting January 27, 2009 Special Session for the Economic Development Delegation**  
**Update and Action Item)**

**LEGISLATIVE ORDER NO. 09-025**

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures**  
2 **to regulate all meetings of the Tohono O'odham Council, standing committees,**  
3 **boards and special committees." (Constitution of the Tohono O'odham Nation,**  
4 **Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council**  
6 **with the authority to "by majority vote, call for a special session" (Legislative Rules**  
7 **of the Tohono O'odham Legislative Council, Article I, Section 1.D.2.); and**

8 **WHEREAS, the Economic Development Delegation has requested a special session for January**  
9 **27, 2009 at 1:00 p.m. for the Economic Development Delegation update and action**  
10 **item; and**

11 **WHEREAS, the Delegation has requested that the update be held in closed session and the**  
12 **action item be addressed off-air.**

13 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby sets a**  
14 **special session for January 27, 2009 at 1:00 p.m. for the Economic Development**  
15 **Delegation update and action item.**

16 **BE IT FURTHER ORDERED that the Economic Development Delegation update will be held in**  
17 **closed session and the action item be addressed off-air.**

18 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup>. Day of**  
19 **JANUARY, 2009 at a meeting at which a quorum was present with a vote of 2,269.7 FOR; -0- AGAINST;**  
20 **-0- NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the Council by Article VI**  
21 **Section 1 (a) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
22 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
23 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
