1 **WHEREAS, at a regular scheduled session of the Tohono O'odham Legislative Council, held in**  
2 **January, 2009; and**

3 **WHEREAS, Baboquivari District presented a budget modification #1 to Artesia/Little Tucson's**  
4 **2009 budget; and**

5 **WHEREAS, at a Baboquivari District Council meeting held on December 17, 2008, the Council**  
6 **present, reviewed, discussed and approved budget modification #1 for Artesia/Little**  
7 **Tucson's 2009 budget; and**

8 **WHEREAS, the budget modification shall be as follows:**

19 **amount of \$294,800.57 and the Baboquivari District's current 2009 total budget**  
20 **amount of \$1,731,310.26; and**

21 **WHEREAS, after review and discussion, the Tohono O'odham Legislative Council did agree to**  
22 **approve Baboquivari District's Artesia/Little Tucson Community 2009 budget**  
23 **modification #1 as identified in the line items above.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**  
25 **Baboquivari District's Artesia/Little Tucson Community 2009 budget modification #1,**  
26 **to decrease line items 610.32 - Salaries of -\$2,065.71 and 660.32 - Travel Expense of -**  
27 **\$1,804.00 and adding to line items 610.32 - Salaries +\$1,749.60; 620.32 - Fringe Benefits**  
28 **+316.11; and 630.32 - Insurance +\$1,804.00.**

29 **BE IT FURTHER RESOLVED that this budget modification #1 does not affect Artesia/Little Tucson's**  
30 **2009 original budget of \$294,800.57, and does not affect the Baboquivari District's 2009**  
31 **current total budget of \$1,731,310.26.**

32 **BE IT FINALLY RESOLVED that any changes in the justifications, additions and/or the transfer of**  
33 **funds between budget line items are to be reviewed by the Budget and Finance**  
34 **Committee and approved by the Tohono O'odham Legislative Council.**
