

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Cardiovascular Disease (CVD) Risk reduction in Diabetes Clients Grant,
Special Diabetes Programs for Indians Competitive Grant # 1 H1D 94 000537-01
(October 2008-September 30, 2009))

RESOLUTION NO. 09-036

1 **WHEREAS, the Tohono O'odham Nation has applied, and been approved to receive, \$397,100 in**
2 **competitive funding from the Special Diabetes Programs for Indians monies; and**

3 **WHEREAS, by Resolution Number 99-149, the Tohono O'odham Legislative Council approved the**
4 **establishment of the Community Based Diabetes Prevention Program, funded by the**
5 **Special Diabetes Programs for Indians, authorized by the balanced Budget Act of 1997;**
6 **and**

7 **WHEREAS, by Resolution Number 2000-1829, the Tohono O'odham Legislative Council approved**
8 **the name change of the Community Based Diabetes Prevention Program, to the**
9 **Healthy O'odham Promotion Program; and**

10 **WHEREAS, by Resolution Number 04-287, the Tohono O'odham Legislative Council approved a**
11 **resolution of support for the above entitled application for funding; and**

12 **WHEREAS, this program is known as the Healthy Heart Project; and**

13 **WHEREAS, the Tohono O'odham Department of Health and Human Services is requesting the**
14 **Fiscal Year 2009 base budget of \$397,100.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 16 **1. Carryover funding amount of \$255,830.12 from FY08, for a new FY09 budget of**
17 **\$652,930.12. Indirect costs have been increased to a total of \$46,808.59.**
- 18 **2. Approves and authorizes expenditures of the Division of Health Promotion**
19 **Program CVD risk reduction (Healthy Heart Project), FY 2009 budget of**
20 **\$652,930.12.**
- 21 **3. Approves additional line items to be added as follows:**
22 **661/710/711/712/714/723/724/730/751/770/771/772/774/813/855/860/867.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham legislative Council hereby approves and**
24 **authorizes the Chairman, Vice-Chairman, and any designated official to expend and**
25 **administer the budget as attached, provided that any amendments affecting the funds**
26 **of funding level shall be submitted for further final approval by the Tohono O'odham**
27 **Legislative Council.**


28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH. Day**
29 **of JANUARY, 2009 at a meeting at which a quorum was present with a vote of 2,340.1 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and 194.4 [06]ABSENT, pursuant to the powers vested in the Council by**
31 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
32 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
34 **Stat. 984).**
