(Approving the Sells District-North Communities Fiscal Year 2009 Budget Amendment
No. 1 to Carry Forward \$11,192.61 from Fiscal Year 2008 to Fiscal Year 2009)

1 **WHEREAS, Sells District-North Communities Resolution No. NC-42-08, Sells District Council**
2 **Resolution No. SD-92-08, Legislative Council Resolution No. 08-572 approved the Sells**
3 **District-North Communities Fiscal Year 2009 Budget and its justification; and**

4 **WHEREAS, at the close of Fiscal Year 2008 the North Communities had a remaining balance of**
5 **\$11,192.61 of their \$30,000.00 budget; and**

6 **WHEREAS, the North Communities has prepared and approved the attached budget amendment**
7 **and its justifications for the remaining balance to be utilized to address the needs of**
8 **the people; and**

9 **WHEREAS, this amendment will increase amounts for the Occasional Appointment,**
10 **Scholarship/Tuition, Tuition/Registration, Travel, Utilities, Supplies Other, Building**
11 **Materials, Capital, Repair and Maintenance of Equipment, Repair and Maintenance**
12 **of Building, Consumables, Special Activities, and Clothing Grant line items.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
14 **Sells District-North Communities Fiscal Year 2009 Budget Amendment No. 1 to Carry**
15 **Forward \$11,192.61 of Gaming Revenues from Fiscal Year 2008 to Fiscal Year 2009 for**
16 **a new Grand Total of \$51,192.61 for Fiscal Year 2009 for the North Communities**
17 **Budget.**

18 **BE IT FURTHER RESOLVED that this will increase the Sells District budget by \$11,192.61 increasing**
19 **the total Sells District budget for Fiscal Year 2009 from \$1,707,656.42 to a total of**
20 **\$1,718,849.03.**

21 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
22 **Chairperson and any designated official to expend and administer the budget, as**
23 **attached, provided that any modifications/amendments affecting the funds or funding**
24 **levels of the budget shall be submitted for further prior approval by the Tohono**
25 **O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH. Day**
27 **of JANUARY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section**
29 **1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
30 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
32 **Stat. 984).**


