

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving an Attorney Contract for 401(K) Matters with Yoder & Langford, P.C. for FY2009)**

RESOLUTION NO. 09-042

1 **WHEREAS, the Tohono O'odham Nation has for several years contracted with the law firm of Yoder**  
2 **& Langford, P.C. for legal services related to the 401(k) Plan of the Nation to assist the**  
3 **401(k) Trustees and the Human Resources Office; and**

4 **WHEREAS, the Attorney Contract for 401(K) is under the oversight of the Attorney General, but is**  
5 **paid for out of the 401(K) budget of the Human Resources Office; and**

6 **WHEREAS, the last such Attorney Contract expired on September 30, 2006; and**

7 **WHEREAS, it is in the best interest of the Nation to continue representation by the Attorney; and**

8 **WHEREAS, the Human Resources Officer and the Attorney General recommend an Attorney**  
9 **Contract with the Attorney in the amount of \$9,000 for the period retroactive from**  
10 **October 1, 2008 through September 30, 2009; and**

11 **WHEREAS, the 401(K) Trustee budget (01-3036-810) has sufficient funds for the contract amount;**  
12 **and**

13 **WHEREAS, the Human Resources Development Committee, the Domestic Affairs Committee and**  
14 **the Budget and Finance Committee recommend approval by the Legislative Council**  
15 **of the Attorney Contract.**

16 **NOW, THEREFORE BE IT RESOLVED THAT:**

- 17 **1. The Tohono O'odham Legislative Council approves the Attorney Contract for 401(K)**  
18 **matters with the law firm of Yoder & Langford, P.C., in the amount of \$9,000 for the**  
19 **period retroactive from October 1, 2008 through September 30, 2009, substantially**  
20 **in the form attached hereto.**
- 21 **2. Funding for the Attorney Contract shall be provided from the 401(K) Trustee**  
22 **budget (Account No. 01-3036-810).**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
24 **Chairman and any designated official to expend and administer the contract as**  
25 **attached provided that any amendments affecting the funds or funding levels of the**  
26 **contract shall be submitted for further prior approval by the Tohono O'odham**  
27 **Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>. Day**  
29 **of JANUARY, 2009 at a meeting at which a quorum was present with a vote of 2,443.95 FOR; -0-**  
30 **AGAINST; 90.55 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
31 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
32 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
34 **18, 1934 (48 Stat. 984).**


