(Approval of the FY 2009 Close Out Budget for the Tohono O'odham Nation
Vocational Rehabilitation Program, Grant Award H250D030012)

RESOLUTION NO. 09-045

1 **WHEREAS, the Tohono O'odham Legislative Council recognizes the need for vocational**
2 **rehabilitation service to enhance the quality of life for individuals with disabilities**
3 **on the Nation; and**

4 **WHEREAS, the Tohono O'odham Legislative Council is committed to enhancing the level of**
5 **service to members of the Tohono O'odham Nation who, due to a disability, may face**
6 **additional challenges in obtaining and maintaining employment; and**

7 **WHEREAS, the Tohono O'odham Education Department submits this Close Out Budget from FY**
8 **2008 Grant Award H250D030012 to be used for the period beginning October 1, 2008**
9 **through December 31, 2008.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
11 **approves the Vocational Rehabilitation Program's FY 2009 Close Out budget in the**
12 **amount of \$77,459.50 and hereby authorizes expenditure of the funds for the period**
13 **retro from October 1, 2008 through December 31, 2008.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
15 **Chairman and any designated official to expend and administer the budget as**
16 **attached, provided that any amendments affecting the funds or funding level shall**
17 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH. Day**
19 **of JANUARY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section**
21 **1(d)(2), (d)(3) and 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
22 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**


