

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
(Setting January 14, 2009 Special Session to Address Gaming Compact Amendments)

LEGISLATIVE ORDER NO. 09-046

1 WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures  
2 to regulate all meetings of the Tohono O'odham Council, standing committees,  
3 boards and special committees." (Constitution of the Tohono O'odham Nation,  
4 Article VI, Section 1(a)); and

5 WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council  
6 with the authority to "by majority vote, call for a special session" (Legislative Rules  
7 of the Tohono O'odham Legislative Council, Article I, Section 1.D.2.); and

8 WHEREAS, the Legislative Council Commerce Committee has requested a special session for  
9 January 14, 2009 at 1:00 p.m. to address gaming compact amendments.

10 NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby sets a  
11 special session on January 14, 2009 at 1:00 p.m. to address gaming compact  
12 amendments.

13 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>. Day of  
14 DECEMBER, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-  
15 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
16 Article VI, Section 1 (a) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
17 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
18 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
19 Stat. 984).
