

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Appointing Willard Anita to the TERO Commission for a Term Expiring**  
**February 1, 2012)**

RESOLUTION NO. 09-050

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "provide for,**  
2 **appoint, or provide for the appointment of, and prescribe the duties and powers of**  
3 **committees, boards, officers and agents" (Constitution of the Tohono Oodham**  
4 **Nation, Article VI, Section 1(b)); and**

5 **WHEREAS, in 1985, the Papago Council enacted the Papago Employment Rights Ordinance**  
6 **("TERO Ordinance"), thereby establishing the Papago Employment Rights**  
7 **Commission (a.k.a., "TERO Commission") and vesting the Council with the power to**  
8 **select and appoint TERO commissioners (TERO Ordinance, Ordinance No. 01-85,**  
9 **Section 6(B)(2)); and**

10 **WHEREAS, Section 6(C) of the TERO Ordinance further provides that "[c]ommissioners shall be**  
11 **appointed for terms of three years, or until their successors are appointed and**  
12 **qualified, provided, however, that appointments to the Commission shall be made**  
13 **in such a way and for such terms that their terms shall be staggered so that the terms**  
14 **of office of only two Commissioners will end in any single year"; and**

15 **WHEREAS, Willard Anita was appointed to the TERO Commission with a term ending February**  
16 **2009 and continues to serve until his successor is appointed and qualified**  
17 **(Resolution No. 08-716); and**

18 **WHEREAS, the Domestic Affairs Committee has been delegated authority to "review and**  
19 **recommend action by the Legislative Council on appointments of . . . TERO**  
20 **Commissioners" (Plan of Operation for the Domestic Affairs Committee, Article III.D.**  
21 **as adopted by Legislative Order No. 01-431); and**

22 **WHEREAS, the Domestic Affairs Committee has recommended that Willard Anita be re-**  
23 **appointed to a term ending February 1, 2012 or until his successor is appointed and**  
24 **qualified.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby appoints**  
26 **Willard Anita to the TERO Commission commencing February 1, 2009 and ending**  
27 **February 1, 2012 or until his successor is appointed and qualified.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup>. Day**  
29 **of JANUARY, 2009 at a meeting at which a quorum was present with a vote of 2,335.3 FOR; -0-**  
30 **AGAINST; -0- NOT VOTING; and 199.2[07] ABSENT, pursuant to the powers vested in the Council by**  
31 **Section 1(b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
32 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
34 **Stat. 984).**
