2 **O'Odham Legislative Council; and**

3 **WHEREAS, on January 27, 2009 a presentation was made to the full council for financial**
4 **contribution for living expenses while attending trade school in the amount of**
5 **\$7,800.00; and**

6 **WHEREAS, the Legislative Council did review the financial request for \$7,800.00.**

7 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
8 **the financial request in the amount of \$7,000.00 to be paid to Van Buren Apartments**
9 **from the Surplus funding.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH. Day**
11 **of JANUARY, 2009 at a meeting at which a quorum was present with a vote of 1,510.5 FOR; 596.9**
12 **AGAINST; 227.9 NOT VOTING; and 199.2[07]ABSENT, pursuant to the powers vested in the Council**
13 **by Section 1(d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**
14 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
15 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
16 **18, 1934 (48 Stat. 984).**






