

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Confirming the Nomination of Frances Stout to the Tohono O'odham Nursing Care
Authority Board of Directors)

RESOLUTION NO. 09-071

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "provide for,**
2 **appoint, or provide for the appointment of, and prescribe the duties and powers of**
3 **committees, boards, officers and agents (Article VI, Section 1(b) Constitution of the**
4 **Tohono O'odham Nation); and**

5 **WHEREAS, the Legislative Council has enacted and subsequently amended the "Charter of the**
6 **Tohono O'odham Nursing Care Authority," which established a Board of Directors**
7 **(Board) which Board shall have ultimate accountability for the management of the**
8 **Nursing Care Authority. (Article IV) (4.1) Charter); and**

9 **WHEREAS, Board members "shall be appointed for terms of four years or until their successors**
10 **are qualified and confirmed. (Article IV (4.2.) 4.2.4); and**

11 **WHEREAS, the Charter provides that the Chairperson of the Nation shall nominate and the**
12 **Legislative Council shall confirm Directors to the Tohono O'odham Nursing Care**
13 **Authority. (Article IV (4.2) 4.2.3); and**

14 **WHEREAS, the Chairman of the Nation has determined that Frances Stout is qualified and is**
15 **nominating Frances Stout, whose term ended on August 30, 2006 (Resolution No. 02-**
16 **487), as one of the Directors of the Tohono O'odham Nursing Care Authority Board;**
17 **and**

18 **WHEREAS, Frances Stout has accepted the nomination upon approval of the Tohono O'odham**
19 **Legislative Council; and**

20 **WHEREAS, the Health and Human Services and Rules Committees of the Legislative Council**
21 **have reviewed the Chairman's nomination.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
23 **accept and approve the confirmation of Frances Stout to the Tohono O'odham**
24 **Nursing Care Authority Board for a four- year term effective on the date of this**
25 **resolution and ending on October 30, 2010, provided that she shall continue to serve**
26 **until replaced by her successor.**

27 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 10TH. Day**
28 **of FEBRUARY, 2009 at a meeting at which a quorum was present with a vote of 2,534.4 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
30 **Section 1(b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
31 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat. 984).**
