a \$24,996.00 award from the Bureau of Land Management for the Solid Waste
Management Program FY 2009 BLM budget 00-0000)

1 **WHEREAS, the Tohono O'odham Nation and the US Bureau of Land Management will enter into**
2 **Cooperative Agreement #L08AC14165 (formerly #AAA080021) to fund undocumented**
3 **migrant trash clean-up from the signing of the agreement through December 30,**
4 **2012; and**

5 **WHEREAS, this cooperative agreement will initially provide an award of \$24,996.00 to the Solid**
6 **Waste Management Program to be expended by April 30, 2009; and**

7 **WHEREAS, the Solid Waste Management Program FY2009 BLM budget 00-0000 has been**
8 **reviewed by the Legislative Natural Resources Committee and the Legislative Budget**
9 **and Finance Committee; and**

10 **WHEREAS, the cooperative agreement #L08AC14165 (formerly #AAA080021) has been reviewed**
11 **by the Legislative Natural Resources Committee, Domestic Affairs Committee and**
12 **the Legislative Budget and Finance Committee.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**
14 **and approves:**

- 15 **1. The cooperative agreement # L08AC14165 (formerly # AAA080021) between the**
16 **Tohono O'odham Nation and the US Bureau of Land Management.**
- 17 **2. The expenditure of an award of \$24,996.00 from the Bureau of Land**
18 **Management for the Solid Waste Management Program FY 2009 BIA budget 00-**
19 **0000, to be expended by April 30, 2009 in accordance with the budget attached**
20 **hereto.**

21 **BE IT FINALLY RESOLVED by the Tohono Legislative Council that the Tohono O'odham Nation's**
22 **Officials, to wit: the Chairperson and any designated official are authorized to**
23 **negotiate and execute the agreement, provided however, that any amendments**
24 **affecting the funds or funding levels of the agreement shall be submitted for further**
25 **approval.**

26 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 10TH. Day**
27 **of FEBRUARY, 2009 at a meeting at which a quorum was present with a vote of 2,534.4 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
29 **Section 1(d)(2)&(3) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**
30 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat. 984).**
