

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 2008 Carry Forward Funds and to Incorporate in FY 2009 Schuk Toak District Budget, Changing the Amount from \$1,707,656.42 to \$2,620,341.08 for FY 2009)**

**RESOLUTION NO. 09-075**

1 **WHEREAS, the Schuk Toak District presented to the Tohono O'odham Legislative Council the**  
2 **District's FY 2008 Carry Forward Amounts; and**

3 **WHEREAS, the Schuk Toak District was allocated Gaming Revenue in the amount of**  
4 **\$1,707,656.42 for FY 2009 and by adding the FY 2006 and FY 2007 Carry Forward**  
5 **amounts for Garcia Strip Community and the FY 2008 Carry Forwards for all nine**  
6 **communities, the Administration and the Summer Youth Program, the new amount**  
7 **will be \$2,620,341.08; and**

8 **WHEREAS, the Schuk Toak District Council at a meeting held on January 12, 2009 with a quorum**  
9 **present, did review and approve Garcia Strip Community's FY 2006 and FY 2007**  
10 **Carry Forward funds and the FY 2008 Carry Forwards for all nine communities, the**  
11 **Administration and the Summer Youth Program; and**

12 **WHEREAS, the following nine communities did present their FY 2008 Carry Forward budgets as**  
13 **part of the new total for FY 2009 District Budgets:**

**7 and will be incorporated into the FY 2009 District Administration Budget, which**  
**8 totals to a new amount of \$1,465,013.04 for FY 2009; and**

**9 WHEREAS, the current combined FY 2009 District's Nine (9) Communities, Summer Youth**  
**10 Program and Administration Budgets in the amount of \$1,707,656.42 has a new**  
**11 amount of \$2,620,341.08 for FY 2009.**

**12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
**13 approves the Schuk Toak District FY 2008 Community Carry Forward Budgets and**  
**14 Garcia Strip's FY 2006 and 2007 Carry Forwards in the total amount of \$1,091,096.44**  
**15 and this amount will be incorporated into the FY 2009 Schuk Toak District Budget.**


1 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves Garcia Strip**

7 **expended in accordance with the attached budgets.**


8 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**

11 **amendments affecting the funding or funding level of this budget shall be submitted**  
12 **for further prior approval by this Council.**

13 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 10<sup>TH</sup>. Day**  
14 **of FEBRUARY, 2009 at a meeting at which a quorum was present with a vote of 2,353.4 FOR; -0-**  
15 **AGAINST; 181.1 NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**  
16 **Section 1(d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
17 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
19 **18, 1934 (48 Stat. 984).**
