

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Intergovernmental Agreement with the Arizona Department of
Economic Security for the One Stop Division of the Education Department)**

RESOLUTION NO. 09-086

1 **WHEREAS, the Tohono O'odham Nation (the "Nation") has negotiated an Intergovernmental**
2 **Agreement ("IGA") with the Arizona Department of Economic Security for the One**
3 **Stop Division of the Education Department; and**

4 **WHEREAS, the Nation will provide Workforce Investment Act (WIA) Title 1-B services to eligible**
5 **Youth, Adults, and Dislocated Workers throughout the reservation effective April 01,**
6 **2008 through June 30, 2011; and**

7 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 08-615 approved the One**
8 **Stop Division Budget in the amount of \$225,520.00 but excluded a negotiated and**
9 **authorized IGA; and**

10 **WHEREAS, the Intergovernmental Agreement was reviewed by the Human Resources**
11 **Development Committee, the Budget & Finance Committee, and the Office of**
12 **Attorney General.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
14 **Intergovernmental Agreement (IGA) between the Tohono O'odham Nation and the**
15 **Arizona Department of Economic Security for a term effective April 1, 2008 through**
16 **June 30, 2011.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Chairman or Vice-Chairman is hereby**
18 **authorized to execute the IGA and any subsequent amendments to extend the term**
19 **of the IGA provided that any amendment affecting the funding or funding levels of**
20 **the budget shall be submitted for approval by the Tohono O'odham Legislative**
21 **Council.**

22 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 11TH Day**
23 **of FEBRUARY, 2009 at a meeting at which a quorum was present with a vote of 2,340.1 FOR; -0-**
24 **AGAINST; 194.4 NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
25 **Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
26 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**
