

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the PY/06 WIA Title V Incentive Funds, Education Department – One**  
**Stop Division Budget/Department of Economic Security- State of Arizona)**

**RESOLUTION NO. 09-087**

1 **WHEREAS, the Tohono O'odham Nation's Education Department – One Stop Division PY 06 WIA**  
2 **Title V Incentive Funds was developed and funded from the Department of Economic**  
3 **Security– State of Arizona Workforce Investment Act (WIA) Title V through projected**  
4 **allocation effective July 01, 2008, and ending June 30, 2009 in the amount of**  
5 **\$22,215.00; and**

6 **WHEREAS, the Department of Economic Security – State of Arizona has released PY 06 Incentive**  
7 **Funds to the NTNWB (Nineteen Tribal Nations Workforce Investment Board) and the**  
8 **Education Department – One Stop Division has been awarded through the NTNWB**  
9 **the amount of \$22,215.00; and now requires a new budget for expenditure; and**

10 **WHEREAS, the Education Department – One Stop Division Budget was reviewed by the Human**  
11 **Resources Development Committee and the Budget & Finance Committee.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
13 **approve and authorize the expenditure of the PY 06 WIA Title V Incentive Funds,**  
14 **Education Department – One Stop Division/Department of Economic Security- State**  
15 **of Arizona Budget of \$22,215.00.**

16 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the PY 06 WIA**  
17 **Title V Incentive Funds, Education Department – One Stop Division/Department of**  
18 **Economic Security- State of Arizona budget.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
20 **Nation's Officials, to wit; the Chairman and any official appointed designee is hereby**  
21 **authorized to expend the budget, provided however, that any amendment affecting**  
22 **the funding or funding levels of this budget shall be submitted for further prior**  
23 **approval by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 11<sup>TH</sup> . Day**  
25 **of FEBRUARY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
27 **Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
30 **18, 1934 (48 Stat. 984).**






