

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2009 Carry Forward Funds for Child Care & Development Fund**  
**for Grant Year 2008 CCDF Unobligated Funds)**

**RESOLUTION NO. 09-089**

1 **WHEREAS, the Tohono O'odham Nation is operating the Division of Early Childhood**  
2 **Development for its young members and providing for their welfare through various**  
3 **programs and services designed to meet their special needs; and**

4 **WHEREAS, the Department of Health and Human Services, Administration for Children and**  
5 **Families has awarded the Tohono O'odham Nation the Child Care & Development**  
6 **Fund for Grant Year 2007 to implement Child Care Services through the Division of**  
7 **Early Childhood Development; and**

8 **WHEREAS, the Child Care & Development Fund is a multi-year grant in which Grant Year 2008**  
9 **remaining funds will be obligated by September 30, 2009 and liquidated by**  
10 **September 30, 2009; and**

11 **WHEREAS, the Division of Early Childhood Development has submitted for review and approval**  
12 **the proposed FY 2009 Carry Forward Funds for Child Care & Development Fund for**  
13 **Grant Year 2008 Discretionary unobligated funds totaling \$53,471.00; and**

14 **WHEREAS, the Grant Year 2008 Discretionary Funds Budget for remaining funds has been**  
15 **reviewed by the Human Resources Development Committee and the Budget and**  
16 **Finance Committee.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
18 **approve the FY 2009 Carry Forward Funds for Child Care & Development Fund for**  
19 **Grant Year 2008 remaining funds for a total of \$53,471.00 for the following budget as**  
20 **attached hereto.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
22 **Nation's Official, to wit: the Chairman and any designated official are authorized to**  
23 **negotiate and expend the budget, provided however, that any amendments affecting**  
24 **the funds or funding levels of the budget shall be submitted for further prior**  
25 **approval.**

26 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 11<sup>TH</sup>. Day**  
27 **of FEBRUARY, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
29 **Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
30 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat. 984).**




