

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(To Amend Enrollment Resolution No. 05-426)

RESOLUTION NO. 09-103

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "enact laws and**
2 **ordinances for governing the enrollment and adoption of members and the**
3 **relinquishment and loss of membership" (Constitution of the Tohono O'odham**
4 **Nation Article VI Section 1(b); and**

5 **WHEREAS, Article VIII, Section 1 of the Enrollment Ordinance No. 5-81 (as amended) provides**
6 **that the Legislative Council shall determine Applicant's eligibility for enrollment or**
7 **adoption; and**

8 **WHEREAS, on August 1, 2005 the Legislative Council pursuant to Resolution No. 05-426,**
9 **approved Vena N. T. Ramon Roll No. 3285-CK-05 for membership in the Tohono**
10 **O'odham Nation; and**

11 **WHEREAS, the Enrollment Committee has determined, based on the individual's date of birth,**
12 **and family tree, Vena N. T. Ramon listed with Roll No. 3285-CK-05 was given the same**
13 **number assigned to another member; (Chavella P. Lewis pursuant to Resolution No.**
14 **05-711); and**

15 **WHEREAS, the Enrollment Manual at page 5, (*Filing of Applications*) provides that once a**
16 **number has been assigned to an application it shall not be changed; and**

17 **WHEREAS, Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O'odham**
18 **Legislative Council shall cause the membership roll be kept current.**

19 **NOW, THEREFORE, BE IT RESOLVED THAT:**

20 **1. The Tohono O'odham Legislative Council approves a modification Resolution No.**
21 **05-426 as follows:**

22 **The Roll No. listed for Chavella P. Lewis shall retain the Roll# 3285-CK-05. The**
23 **Roll No. listed for Vena N. T. Ramon be changed to 3287-CK-05 to reflect the**
24 **number originally assigned to the application of Vena N. T. Ramon August 1, 2005**
25 **which was approved by this Council pursuant to Resolution No. 05-426.**

26 **2. The Enrollment Committee shall make the necessary changes in the records of**
27 **the Enrollment Office to incorporate the stated modification.**

28 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 09TH. Day**
29 **of MARCH, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
31 **Section 1 of Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'Odham**
32 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
33 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**
34 **of the Act of June 18, 1934 (48 Stat. 984).**
