

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Resolution 08-277 (Approving the FY 2009 Department of Health and  
Human Services Title IV-B Subparts 1 & 2 budgets for Division of Child Welfare;  
and Approving the 10% Indirect Cost Rate for Title IV B Budgets))**

**RESOLUTION NO. 09-117**

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
2 **Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a Division**  
4 **of Child Welfare Services to intervene against child abuse and neglect and to promote**  
5 **safe and stable families; and**

6 **WHEREAS, the current budget obligating the account numbers for Title IV-B Subpart 1 Budget**  
7 **Acct. 11-1337 and Title IV-B Subpart 2 Budget Acct. 11-1338 were approved under**  
8 **resolution number 08-277 on June 09, 2008; and**

9 **WHEREAS, the temporary account number for the following line items shall be as follows:**

- 10 **1. FY09 Title IV-B, Subpart 1 Budget from Acct. number 11-1337 to FY09 Title IV-B,**  
11 **Subpart 1 Budget Acct. number 00-0000.**
- 12 **2. FY09 Title IV-B, Subpart 2 Budget Acct. number 11-1338 to FY09 Title IV-B, Subpart**  
13 **2 Budget Acct. number 00-0000.**

14 **WHEREAS, the Executive Branch developed and obtained committee approval of the budgets**  
15 **attached and incorporated by this reference, to be effective October 1, 2008 through**  
16 **September 30, 2010 and requests authorization to expend funds over the fiscal year**  
17 **of FY 2010.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
19 **approve amending Resolution 08-277 (Approving the FY 2009 Department of Health**  
20 **and Human Services Title IV-B Subparts 1 & 2 budgets for Division of Child Welfare;**  
21 **and Approving the 10% Indirect Cost Rate for Title IV B Budgets) reflecting the**  
22 **following changes:**

- 23 **1. FY09 Title IV-B, Subpart 1 Budget from Acct. number 11-1337 to FY09 Title IV-B,**  
24 **Subpart 1 Budget Acct. number 00-0000.**
- 25 **2. FY09 Title IV-B, Subpart 2 Budget Acct. number 11-1338 to FY09 Title IV-B, Subpart**  
26 **2 Budget Acct. number 00-0000.**

27 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairman and any**  
28 **designated official are hereby authorized to negotiate, execute and expend the grant,**  
29 **provided however, that any budget amendments affecting the funds or funding levels**  
30 **shall be submitted for further prior approval by the Tohono O'odham Legislative**  
31 **Council.**
