

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Sells District-Cowlic Community Fiscal Year 2009 Budget Amendment
No. 1 to Carry Forward Gaming Revenues in the amount of \$18,275.83 from Fiscal
Year 2008 to Fiscal Year 2009)

RESOLUTION NO. 09-118

1 WHEREAS, Cowlic Community Resolution No. CC-46-08, Sells District Council Resolution No. SD-
2 91-08, and Legislative Council Resolution No. 08-572 approved the Sells District-Cowlic
3 Community Fiscal Year 2009 Budget and its justification; and

4 WHEREAS, at the close of Fiscal Year 2008 the Cowlic Community had a remaining balance of
5 \$18,275.83 of their \$30,000.00 budget; and

6 WHEREAS, the attached budget amendment and its justifications has been prepared and
7 approved by the Cowlic Community with Resolution No. CC-02-09; by the Sells District
8 Council with Resolution No. SD-13-09 approving a carry forward of the remaining
9 balance to be utilized to address the additional needs of the people.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
11 Sells District-Cowlic Community Fiscal Year 2009 Budget Amendment No. 1 to Carry
12 Forward \$18,275.83 of Gaming Revenues from Fiscal Year 2008 to Fiscal Year 2009 for
13 a new Grand Total of \$58,275.83 for Fiscal Year 2009 for the Cowlic Community Budget.

14 BE IT FURTHER RESOLVED that this will increase the Sells District budget by \$18,275.83 adjusting
15 the total Sells District budget for Fiscal Year 2009 from \$1,718,849.03 to a new Grand
16 Total of \$1,737,124.86.

17 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Sells
18 District Chairperson and any designated official to expend and administer the budget,
19 as attached, provided that any modifications/amendments affecting the funds or
20 funding levels of the budget shall be submitted for further prior approval by the
21 Tohono O'odham Legislative Council.

22 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH of
23 MARCH, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;
24 -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,
25 Section 1 (d)(2)&(3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
26 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
27 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
28 Stat. 984).
