

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Certifying Appointment of Evonne Wilson as Legislative Council Secretary)**

LEGISLATIVE ORDER NO. 09-121

1 **WHEREAS, the Constitution of the Tohono O'odham Nation authorizes the Legislative Council**
2 **to "select from outside of its own membership a secretary" to "serve until replaced**
3 **by the council" (Constitution, Article V, Section 5); and**
4 **WHEREAS, the Legislative Council interviewed Evonne Wilson for the position of Legislative**
5 **Council Secretary; and**
6 **WHEREAS, if selected, Evonne Wilson will serve as the Legislative Council Secretary until**
7 **replaced by the Legislative Council in accordance with the Nation's Constitution.**
8 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it**
9 **certifies and appoints Evonne Wilson as the Legislative Council Secretary; provided**
10 **that she shall serve until May 2009 and or replaced by the Legislative Council.**

11 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 11TH Day of**
12 **MARCH, 2009 at a meeting at which a quorum was present with a vote of 1,241.35 FOR; 659.0**
13 **AGAINST; 634.15 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
14 **Article V, Section 5 of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
15 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
16 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
17 **Stat. 984).**
