1 **WHEREAS, at a regular scheduled session of the Tohono O'odham Legislative Council held in**
2 **March 2009; and**

3 **WHEREAS, the Baboquivari District brought forward a request for a budget modification #2 to**
4 **Artesia/Little Tucson's 2009 current budget; and**

5 **WHEREAS, at a Baboquivari District Council meeting held on February 18, 2009 this budget**
6 **modification #2 was presented, discussed and approved by Council members**
7 **present by a vote count of 10-For, 0-Against, 0-Not Voting, 2-Absent; and**

8 **WHEREAS, this budget modification #2 will apply to the following line items:**

15 **budget amount of \$294,800.57 or the overall Baboquivari District 2009 current**
16 **budget amount of \$1,954,116.68.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
18 **Artesia/Little Tucson 2009 budget modification #2 to utilize \$11,100.00 from line**
19 **item 750.32-Major Capital and apply this amount to line items 612.32 Occasional**
20 **Appt-\$10,000.00 and 620.32 Fringe Benefits-\$1,100.00.**

21 **BE IT FURTHER RESOLVED that this budget modification #2 does not affect the current 2009**
22 **budget amount for Artesia/Little Tucson of \$294,800.57 and the overall Baboquivari**
23 **District 2009 current budget amount of \$1,954,116.68.**

24 **BE IT FINALLY RESOLVED that any changes in the modifications, amendments, justifications and**
25 **line items shall be reviewed and approved by the Budget & Finance Committee and**
26 **the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 12TH Day**
28 **of MARCH, 2009 at a meeting at which a quorum was present with a vote of 2,448.5 FOR; -0-**
29 **AGAINST; 86.0 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
30 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
31 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat. 984).**
