

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Appointment of Mr. Gary Quinn as Executive Director for Tohono  
O'odham Nation Department of Health & Human Services)**

**RESOLUTION NO. 09-133**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation provides the Chairman of the Tohono**  
2 **O'odham Nation the authority to appoint heads of governmental departments with the**  
3 **approval of the Tohono O'odham Legislative Council (Article VII Section 2e); and**

4 **WHEREAS, the Chairman of the Tohono O'odham Nation, in consultation with the Tohono**  
5 **O'odham Legislative Health & Human Services Committee, has identified Mr. Gary**  
6 **Quinn as the appointee for the Nation's the Executive Director for Tohono O'odham**  
7 **Nation Department of Health & Human Services; and**

8 **WHEREAS, Mr. Gary Quinn is qualified to assume the position of Executive Director for the**  
9 **Tohono O'odham Nation Department of Health & Human Services; and**


10 **WHEREAS, Mr. Gary Quinn has accepted the position and appointment upon approval of the**  
11 **Tohono O'odham Legislative Council.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
13 **approve the appointment of Mr. Gary Quinn as Executive Director for the Tohono**  
14 **O'odham Nation Department of Health & Human Services.**

15 **BE IT FURTHER RESOLVED that Mr. Gary Quinn shall serve at the pleasure of the Chairman of the**  
16 **Tohono O'odham Nation.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day**  
18 **of MARCH, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
19 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Section**  
20 **2 (e) of Article VII of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
21 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
22 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
23 **Stat. 984).**
