

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving of FY2009 Mining Royalties Budgets for the Four Communities of the Sells District: Cowlic, Ge Oidag, North Communities, and Sells in the amount of \$266,596.95)**

**RESOLUTION NO. 09-140**

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 07-752 approved the Equal**  
2 **Distribution of \$2,932,566.45 of Mining Royalties to the eleven Districts of the**  
3 **Tohono O'odham Nation; and**

4 **WHEREAS, the Sells District's portion of this allocation in the amount of \$266,596.95 was not**  
5 **requested in Fiscal Year 2008; and**

6 **WHEREAS, the communities of the Sells District have identified the needs of the communities**  
7 **and have submitted the attached budgets and their justifications in the amount of**  
8 **\$66,649.23 for Cowlic Community and \$66,649.24 for each of the Ge Oidag**  
9 **Community, North Communities, and the Sells Community; and**

10 **WHEREAS, Sells District Council has reviewed and approved, the attached budgets and their**  
11 **justifications for the four communities.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
13 **Fiscal Year 2009 Mining Royalties Budgets as submitted and attached for the four**  
14 **communities of the Sells District: Cowlic, Ge Oidag, North Communities, and Sells in**  
15 **the total amount of \$266,596.95.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
17 **Sells District Chairperson and any designated official to expend and administer the**  
18 **budget according to its justification, as attached, provided that any**  
19 **modifications/amendments affecting the funds or funding levels of the budget shall**  
20 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 13<sup>TH</sup>. Day**  
22 **of MARCH, 2009 at a meeting at which a quorum was present with a vote of 2,443.95 FOR; -0-**  
23 **AGAINST; 90.55 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
24 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
27 **18, 1934 (48 Stat. 984).**
