4 **their FY' 2009 Budget to assist the District Members; and**


5 **WHEREAS, the proposed amendment from the Administration has gone through proper reviews**

9 **#1 for Gu-Vo District Administration.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
11 **approves the Budget Amendment #1 for Gu-Vo District Administration and**
12 **adjusting the amount in the justification of line items; 624, 720, 724, 750, 850, 852,**
13 **860, in their FY' 2009 Budget.**

14 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 13TH Day**
15 **of MARCH, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
16 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
17 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
18 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
20 **18, 1934 (48 Stat. 984).**
