

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Kukatch Community Carry Over Mining Royalty Budget
FY'2008 for FY'2009)

RESOLUTION NO. 09-146

1 **WHEREAS, the Gu-Vo District Governing Council did meet on September 20, 2008 to approve**
2 **Kukatch Community Carry Over Mining Royalty Budget FY'2008 to be carried into**
3 **FY'2009; and**

4 **WHEREAS, the Gu-Vo District Governing Council has determined that it is in the best interest**
5 **of the Kukatch Community to request to the Tohono O'odham Legislative Council to**
6 **grant Kukatch Community to Carry Over FY'2008 Mining Royalty Budget in the**
7 **amount of \$19,423.32 into FY'2009.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approve**
9 **the Kukatch Community FY'2008 Mining Royalty Budget Carry Over in the amount**
10 **of \$19,423.32 into FY'2009.**

11 **BE IT FINALLY RESOLVED that the Gu-Vo District reserves the right to modify its budget according**
12 **to the Tohono O'odham Nation's process, but any amendments affecting the funds**
13 **or funding levels shall be approved by the Legislative Council.**

14 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 18TH Day**
15 **of MARCH, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
16 **AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by**
17 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
18 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
20 **18, 1934 (48 Stat. 984).**
