1 **WHEREAS, Sells District-North Communities Resolution No. NC-42-08; Sells District Council**
2 **Resolution No. SD-92-08; Legislative Council Resolution No. 08-572 approved the**
3 **Sells District-North Communities Fiscal Year 2009 Budget and its justification; and**

4 **WHEREAS, Sells District-North Communities Resolution No. NC-05-08; Sells District Council**
5 **Resolution No. SD-124-08; Legislative Council Resolution No. 09-039 approved the**
6 **Sells District-North Communities Fiscal Year 2009 Budget Amendment No. 1 and its**
7 **justification for the carryover of the remaining balance of their FY08 budget to Fiscal**
8 **Year 2009; and**

9 **WHEREAS, the North Communities has prepared and acquired approvals of the attached budget**
10 **Modification/Amendment and its justification with North Communities Resolution**
11 **No. NC-33-08; Sells District Council Resolution No. SD-127-08; for adjustments to**
12 **address the needs of the people; and**

13 **WHEREAS, this Modification/Amendment will increase the amount for the Occasional**
14 **Appointment line item which will reduce the Building Materials line item and the**
15 **Emergency Assistance line item.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **Sells District-North Communities Fiscal Year 2009 Budget Modification No.**
18 **1/Amendment No. 2 of Gaming Revenues for the North Communities Budget.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
20 **Sells District Chairperson and any designated official to expend and administer the**
21 **budget, as attached, provided that any modifications/amendments affecting the**
22 **funds or funding levels of the budget shall be submitted for further prior approval**
23 **by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 18TH. Day**
25 **of MARCH, 2009 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**
