**RESOLUTION NO. 17-005**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members (Article II,**  
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**  
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**  
6 **Enrollment Committee is responsible for reviewing enrollment applications**  
7 **and making recommendations to the Legislative Council regarding the**  
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**  
9 **and**

10 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**  
11 **O'odham Legislative Council shall determine whether an application is**  
12 **approved for membership and its determination, along with the resolution**  
13 **number and date of enactment, shall be provided to the applicant; and**

14 **WHEREAS, the Enrollment Program has determined that a number of resolutions**  
15 **approving membership and adoption applications misspelled or incorrectly**  
16 **listed the names of members and/or incorrectly listed enrollment numbers; and**

17 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 129-83, 27-**  
18 **84, 97-322, 99-140, 99-200, 99-311, 99-420, 99-475, 2000-035, 2000-083, 2000-176,**  
19 **01-589, 13-243 and 14-396 be amended to reflect the correct name and/or**  
20 **enrollment number for the members identified in the January 2017 Corrected**  
21 **Enrollment Resolution Summary, which is incorporated by this reference.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**  
23 **Resolution Nos. 129-83, 27-84, 97-322, 99-140, 99-200, 99-311, 99-420, 99-475,**  
24 **2000-035, 2000-083, 2000-176, 01-589, 13-243 and 14-396 are amended upon the**  
25 **effective date of those resolutions to reflect the correct name and/or enrollment**  
26 **number for the members identified in the January 2017 Corrected Enrollment**  
27 **Resolution Summary.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup>**  
29 **day of JANUARY, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**  
30 **-0- AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**  
31 **Article II, Section 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**  
32 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**  
33 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**  
34 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**




