

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Chukut Kuk District Budget Amendment #1)

RESOLUTION NO. 17-010

1 **WHEREAS, Pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation,**

3 "No District shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only
6 by a treasurer of other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation and all expenditure of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council"

11 ; and

12 **WHEREAS, the Tohono O'odham Legislative Council approved Resolution No. 16-465**
13 **Approving FY 2017 Chukut Kuk District Budgets; and**

14 **WHEREAS, by Chukut Kuk District Resolution No. 2016-53 the Chukut Kuk District has**
15 **prepared and submitted for review and approval its FY 2017 Budget Amendment**
16 **No. 1, which is incorporated by this reference and which (1) increases personnel**
17 **line items; (2) decreases operational line items; (3) incorporates additional**
18 **language in the justification; and**

19 **WHEREAS, The Chukut Kuk District Council approved Resolution No. 2016-53 approving FY**
20 **2017 Chukut Kuk District Budget Amendment No. 1 transferring identified**
21 **savings to various line items to cover anticipated costs; and**

22 **WHEREAS, the Budget and Finance Committee reviewed the FY 2017 Chukut Kuk District**
23 **Budget Amendment No. 1 and recommends its approval.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
25 **approves FY 2017 Chukut Kuk District Budget Amendment No. 1 transferring**
26 **\$2,067.77 to various line items to cover anticipated costs.**


27 **BE IT FURTHER RESOLVED that this amendment does not affect the overall approved FY 2017**

32 **funds or funding level of the FY 2017 Chukut Kuk District Budget shall be**
33 **submitted to the Tohono O'odham Legislative Council for prior approval.**

7 **18, 1934 (48 Stat.984).**


