

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Fiscal Year 2017 Gu Achi District Budget Amendment #1 for**  
**Cababi Community)**

**RESOLUTION NO. 17-016**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 "No District shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only  
6 by a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation and all expenditure of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council"; and

11 **WHEREAS,** the Fiscal Year 2017 Gu Achi District Budget in the amount of \$2,178,486.42 was  
12 authorized by Tohono O'odham Legislative Council No 16-460; and

13 **WHEREAS,** the Gu Achi District Council approved Resolution No. 1216-181 approving Fiscal  
14 Year 2017 Gu Achi District Budget Amendment No. 1 for Cababi Community; and

15 **WHEREAS,** the Gu Achi District has prepared and submitted for review and approval its  
16 Fiscal Year 2017 Budget Amendment No. 1, which is incorporated by this  
17 reference and which (1) decreases 7355 Professional Services line item; and (2)  
18 increases 7060 Food, 7110 Utilities, 7420 RM Building and 7676 School Supplies;  
19 and

20 **WHEREAS,** the Budget and Finance Committee reviewed the attached budget amendment  
21 and recommend its approval.

22 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council does hereby  
23 approves Fiscal Year 2017 Gu Achi District Budget Amendment #1 for Cababi  
24 Community as attached.

25 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council hereby authorizes the  
26 District Chairperson and any designated official to expend and administer the  
27 Budget as attached, provided that any modifications/amendments affecting the  
28 funds or funding level is submitted for further prior approval by the Tohono  
29 O'odham Legislative Council.
