

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Public Safety, Law Enforcement, U.S. Department
of Justice, Office of Community Oriented Policing Services, Coordinated Tribal
Assistance Solicitation Purpose Area #1: COPS Tribal Resource Grant Program -
Equipment/Training Budget)**

RESOLUTION NO. 17-018

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to
3 appropriate these funds for the benefit of the nation and its members" provided
4 that "[a]ll expenditures of these funds shall be pursuant to appropriations or
5 budgets" authorized by resolution or ordinance (Constitution of the Tohono
6 O'odham Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2017 Department of Public Safety ("DPS"), Law Enforcement, U. S.
8 Department of Justice ("DOJ"), Office of Community Oriented Policing Services
9 ("COPS"), Coordinated Tribal Assistance Solicitation ("CTAS") Purpose Area #1:
10 COPS Tribal Resource Grant Program ("TRGP") - Equipment/Training, Award No.
11 2015HEWX0021, in the amount of \$570,042.00 was accepted and approved by
12 Resolution No. 15-481; and

13 **WHEREAS,** the DPS Law Enforcement Program has prepared and submitted for review and
14 approval its FY 2017 DPS Law Enforcement DOJ COPS CTAS Purpose Area #1:
15 COPS TRGP - Equipment/Training Budget, which is incorporated by this
16 reference, in the amount of \$570,042.00 to be funded from the Nation's general
17 fund; and

18 **WHEREAS,** the Domestic Affairs and the Budget and Finance Committees have reviewed the
19 FY 2017 DPS Law Enforcement DOJ COPS CTAS Purpose Area #1: COPS TRGP -
20 Equipment/Training Budget and recommend its approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
22 FY 2017 DPS Law Enforcement DOJ COPS CTAS Purpose Area #1: COPS TRGP -
23 Equipment/Training Budget in the amount of \$570,042.00, which shall be funded
24 by the Nation's general fund.

25 **BE IT FURTHER RESOLVED** that the Tohono O'odham Legislative Council authorizes the DPS
26 Law Enforcement Program to expend funds from the attached budget for the
27 period of September 1, 2016 through August 31, 2017 on a direct cost
28 reimbursement basis and to utilize the Nation's resources pending
29 reimbursement from the Grantor for the continuation of this grant.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH day of JANUARY, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
