

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Tohono O'odham Nation Health Care Sells Dental Services
Budget Amendment No. 1)**

RESOLUTION NO. 17-020

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to
3 appropriate these funds for the benefit of the nation and its members" provided
4 that "[a]ll expenditures of these funds shall be pursuant to appropriations or
5 budgets" authorized by resolution or ordinance (Constitution of the Tohono
6 O'odham Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2017 Tohono O'odham Nation Health Care ("TONHC") Sells Dental Services
8 Budget in the amount of \$2,916,566.44 was approved by Resolution No. 16-524;
9 and

10 **WHEREAS,** the Sells Dental Services has prepared and submitted for review and approval its
11 FY 2017 Budget Amendment No. 1, which is incorporated by this reference and
12 which will adjust an operational line item; and

13 **WHEREAS,** the FY 2017 TONHC Sells Dental Services Budget Amendment No. 1 will increase
14 the FY 2017 TONHC Sells Dental Services Budget by \$700,000.00 from
15 \$2,916,566.44 to \$3,616,566.44; and

16 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
17 reviewed the FY 2017 TONHC Sells Dental Services Budget Amendment No. 1 and
18 recommend its approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
20 FY 2017 TONHC Sells Dental Services Budget Amendment No. 1, which includes a
21 \$700,000.00 increase from \$2,916,566.44 to \$3,616,566.44 that shall be funded by
22 Self-Governance Surplus Funds.


23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono
24 O'odham Nation chairperson or any designated official is authorized to
25 administer and expend the FY 2017 TONHC Sells Dental Services Budget as
26 amended, provided however, that any amendments or modifications shall be
27 submitted to the Tohono O'odham Legislative Council for prior approval.


