

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2017 Tribal Employment Rights Commission Budget)**

**RESOLUTION NO. 17-022**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Office of the Chairman prepared and submitted for review and approval its**  
8 **FY 2017 Tribal Employment Rights Commission Budget, which is incorporated**  
9 **by this reference, in the amount of \$88,195.11 to be funded through Tribal**  
10 **Employment Rights Ordinance ("TERO") fees; and**

11 **WHEREAS, the Human Resources Development and the Budget and Finance Committees**  
12 **have reviewed the FY 2017 Tribal Employment Rights Commission Budget and**  
13 **recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
15 **FY 2017 Tribal Employment Rights Commission Budget, effective October 1,**  
16 **2016, in the amount of \$88,195.11, which shall be funded by TERO fees.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
18 **O'odham Nation chairperson or any designated official is authorized to**  
19 **administer and expend the FY 2017 Tribal Employment Rights Commission**  
20 **Budget, provided however, that any amendments or modifications shall be**  
21 **submitted to the Tohono O'odham Legislative Council for prior approval.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>**  
23 **day of JANUARY, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**  
24 **-0- AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**  
25 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
26 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
28 **June 18, 1934 (48 Stat.984).**
