

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2017 Executive Branch Miss Tohono O'odham Nation Budget**  
**Amendment No. 1)**

**RESOLUTION NO. 17-024**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, FY 2017 Executive Branch Miss Tohono O'odham Nation Budget in the amount of**  
8 **\$57,603.78 was approved by Resolution No. 16-322; and**

9 **WHEREAS, the Executive Branch has prepared and submitted for review and approval its FY**  
10 **2017 Miss Tohono O'odham Nation Budget Amendment No. 1, which is**  
11 **incorporated by this reference and will (1) adjust operational line items; and (2)**  
12 **include additional language in the justification for line items 6700 Awards-**  
13 **Clients, 7355 Professional Services; and**

14 **WHEREAS, the FY 2017 Executive Branch Miss Tohono O'odham Nation Budget Amendment**  
15 **No. 1 will not change the total budget amount; and**

16 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**  
17 **reviewed the FY 2017 Executive Branch Miss Tohono O'odham Nation Budget**  
18 **Amendment No. 1 and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
20 **FY 2017 Executive Branch Miss Tohono O'odham Nation Budget Amendment No.**  
21 **1 which does not change the total budget amount.**

22 **BE IT FURTHER RESOLVED that amendment No. 1 will adjust operational line items and include**  
23 **additional language in the justification for line items 6700 Awards-Clients, 7355**  
24 **Professional Services.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
26 **Nation chairperson or any designated official is authorized to administer and**  
27 **expend the FY 2017 Executive Branch Miss Tohono O'odham Nation Budget as**  
28 **amended, provided however, that any amendments or modifications shall be**  
29 **submitted for prior approval by the Tohono O'odham Legislative Council.**


1 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup> day**

7 **18, 1934 (48 Stat.984).**


