

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Committee Memberships Certified by Legislative Order No. 15-228, "Certifying  
Elections of Council Representatives to the Legislative Council Standing Committees,  
Certifying Committee Officers, and Seating Council Representatives to Committee  
Memberships")**

**LEGISLATIVE ORDER NO. 17-039**

1   **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to establish**  
2                   **rules and procedures to regulate all meetings of the Council and its standing**  
3                   **committees (Constitution, Article VI, Section 1(a)); and**

4   **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council ("Legislative**  
5                   **Rules") provide that "upon the certification of elected officers, the Legislative**  
6                   **Council shall, in alphabetical order of the current legislative committees,**  
7                   **proceed with the election of legislative committee members" by the process of**  
8                   **retention, seniority, and other means (Legislative Rules, Article XII, Section 3);**  
9                   **and**

10   **WHEREAS, on June 12, 2015, the Legislative Council elected committee members and officers**  
11                   **to the twelve standing committees in accordance with Article XII, Section 3 of the**  
12                   **Legislative Rules (Legislative Order No. 15-228, as amended by Legislative Order**  
13                   **No. 16-052 and 16-074); and**

14   **WHEREAS, pursuant to Legislative Rules Article XII, Section 3(L)(3), "When a Legislative**  
15                   **Council representative ceases serving as a Legislative Council officer during his**  
16                   **or her term as an officer, that representative shall be appointed to the legislative**  
17                   **committees of his or her successor."; and**

18   **WHEREAS, Rep. Vernon J. Smith has ceased serving as the Legislative Council vice-**  
19                   **chairperson and has been replaced in that office by Rep. Lucinda J. Allen**  
20                   **(Legislative Order No. 17-038).**

21   **NOW, THEREFORE, BE IT ORDERED that pursuant to Legislative Rules Article XII, Section 3(L)(3),**  
22                   **the Tohono O'odham Legislative Council appoints Rep. Vernon J. Smith to the**  
23                   **following committee memberships: Appropriations, Domestic Affairs, Water**  
24                   **Resources.**

25   **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 31<sup>ST</sup> day of**  
26   **JANUARY, 2017 at a meeting at which a quorum was present with a vote of 2,815.6 FOR; -0-**  
27   **AGAINST; -0- NOT VOTING; and 205.8[03] ABSENT, pursuant to the powers vested in the Council**  
28   **by Article V, Section 4 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
29   **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
30   **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**  
31   **(48 Stat.984).**


