

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Setting March 1, 2017 Special Session to Address Appointments to the Community  
Development Financial Institution Board of Directors, Economic Development  
Authority Board of Directors, Tohono O'odham Utility Authority Management  
Board and Gaming Office Executive Director)**

**LEGISLATIVE ORDER NO. 17-042**

1 **WHEREAS,** the Legislative Council is vested with the power "to establish rules and  
2 procedures to regulate all meetings of the Tohono O'odham Council, standing  
3 committees, boards and special committees." (Constitution of the Tohono  
4 O'odham Nation, Article VI, Section 1(a)); and

5 **WHEREAS,** the Legislative Rules of the Tohono O'odham Legislative Council vests the Council  
6 with the authority to "by majority, call for a special session" (Legislative Rules of  
7 the Tohono O'odham Legislative Council, Article I, Section 1.D.1); and

8 **WHEREAS,** the Commerce Committee has requested a special session on March 1, 2017 to  
9 address the appointments of candidates for the following:

- 10 1. Community Development Financial Institution Board of Directors
- 11 2. Economic Development Authority Board of Directors
- 12 3. Tohono O'odham Utility Authority Management Board
- 13 4. Gaming Office Executive Director

14 **NOW, THEREFORE, BE IT ORDERED** by the Tohono O'odham Legislative Council that it sets a  
15 special session on March 1, 2017 to address the appointments of candidates to the  
16 Community Development Financial Institution Board of Directors, Economic  
17 Development Authority Board of Directors, Tohono O'odham Utility Authority  
18 Management Board and the Gaming Executive Director.

19 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup> day of**  
20 **FEBRUARY, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
22 **Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the**  
23 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
25 **18, 1934 (48 Stat.984).**
