

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution Nos. 114-80, 127-83, 97-460, 98-357, 99-420,
99-475, and 01-543 to Reflect Legal Name Changes of Enrolled Members)**

RESOLUTION NO. 17-045

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article II,**
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications**
7 **and making recommendations to the Legislative Council regarding the**
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**
9 **and**

10 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**
11 **O'odham Legislative Council shall determine whether an application is**
12 **approved for membership and its determination, along with the resolution**
13 **number and date of enactment, shall be provided to the applicant; and**

14 **WHEREAS, the Enrollment Program has received the official documents showing the legal**
15 **name changes of enrolled members due to a variety of reasons, such as**
16 **marriage, divorce, or legal adoption; and**

17 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 114-80,**
18 **127-83, 97-460, 98-357, 99-420, 99-475, and 01-543 be amended to reflect the**
19 **amended names for the members identified in the February 2017 Amended**
20 **Enrollment Resolution Summary, which is incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**
22 **Resolution Nos. 114-80, 127-83, 97-460, 98-357, 99-420, 99-475, and 01-543 are**
23 **amended upon the effective date of those resolutions to reflect the legal name**
24 **changes for the members identified in the February 2017 Amended Enrollment**
25 **Resolution Summary.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
27 **day of FEBRUARY, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
28 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
29 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**
30 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**
31 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**
32 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
