

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Ge Oidag Community FY 2017 INT-01-14 Budget carryover from**  
**FY 2016 in the amount of \$31,565.02)**

**RESOLUTION NO. 17-050**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation, "No district council shall expend district funds except pursuant to  
3 budgets authorized under resolutions of the district council and approved by  
4 the Tohono O'odham Council. The management of these funds shall be only by a  
5 treasurer or other authorized officer of the district council who has furnished a  
6 surety bond satisfactory to the treasurer of the Tohono O'odham Nation, and all  
7 expenditures of these funds shall be by checks signed by such treasurer or other  
8 authorized officer and the chairman or vice chairman of the district council";

10 **WHEREAS,** Sells District, Ge Oidag Community Resolution No. GO-32-2016, Sells District  
11 Council Resolution No. SD-44-16 and Tohono O'odham Legislative Council  
12 Resolution No. 16-2021 approved Ge Oidag's Fiscal Year 2016 INT-01-14 Budget  
13 and it's justifications; and

14 **WHEREAS,** Ge Oidag Community did not expend any funding allocated in their FY 2016 INT-  
15 01-14 budget and are seeking to carryover the budgeted amount of \$31,565.02 to  
16 address more home renovations; and

17 **WHEREAS,** Ge Oidag Community has prepared and acquired approvals of the attached  
18 budget to carry over the INT-01-14 funds from FY 2016 to FY 2017 with Ge Oidag  
19 Community Resolution No. GO-20-17 and Sells District Council Resolution No.  
20 SD-102-16; and

21 **WHEREAS,** the Budget and Finance Committee of the Tohono O'odham Legislative Council  
22 has reviewed the budget and recommends its approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves  
24 the Ge Oidag Community FY 2017 INT-01-14 Budget carryover from FY 2016 in  
25 the amount of \$31,565.02.

26 **BE IT FINALLY RESOLVED,** that the Tohono O'odham Legislative Council hereby authorizes the  
27 Sells District Chairperson and any designated District Official to expend and  
28 administer the budget as attached, provided that any modifications or  
29 amendments affecting the funds or funding levels of the budget shall be
