

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2017 Attorney Contract between the Tohono O'odham Nation and
The Clark Law Firm, P.C.)

RESOLUTION NO. 17-059

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the power "to employ legal counsel for the protection and advancement of**
3 **the Tohono O'odham Nation..." (Constitution of the Tohono O'odham Nation,**
4 **Article VI, Section 2(a)); and**

5 **WHEREAS, it is advisable that the Human Resources Department has available**
6 **independent legal representation for employment issues in which the Office of**
7 **Attorney General is unable to provide legal advice due to conflicts of interest;**
8 **and**


9 **WHEREAS, the Human Resources Department prepared and submitted for review an**
10 **Attorney Contract with The Clark Law Firm, P.C. to provide legal representation**
11 **to the Human Resources Department; and**

12 **WHEREAS, the Human Resources Development and the Budget and Finance Committees**
13 **have reviewed the Attorney Contract and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **FY 2017 Attorney Contract between the Tohono O'odham Nation and The Clark**
16 **Law Firm, P.C., in substantially the form attached, and that the Chairman of the**
17 **Nation is authorized to execute the Attorney Contract.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
19 **day of FEBRUARY, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
20 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
21 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
22 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
24 **June 18, 1934 (48 Stat.984).**
