

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2017 Attorney Contract between the Tohono O'odham Nation
and Yoder & Langford, P.C. regarding 401(k) Matters)

RESOLUTION NO. 17-060

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the power "to employ legal counsel for the protection and advancement of**
3 **the Tohono O'odham Nation..." (Constitution, Article VI, Section 2(a)); and**

4 **WHEREAS, the Tohono O'odham Nation has for several years contracted with the law firm of**
5 **Yoder & Langford, P.C. for legal services related to the Nation's 401(k) in order to**
6 **assist the 401(k) Trustees and the Human Resources Department; and**

7 **WHEREAS, the Human Resources Department has prepared and submitted for review an**
8 **Attorney Contract with Yoder & Langford to continue to provide legal services**
9 **related to the Nation's 401(k) Plan; and**

10 **WHEREAS, the Attorney Contract regarding 401(k) matters is under the oversight of the**
11 **Attorney General, but is paid for out of the Human Resources Department**
12 **Budget; and**

13 **WHEREAS, the Human Resources Development and the Budget and Finance Committees**
14 **have reviewed the Attorney Contract and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council approves the**
16 **Attorney Contract regarding 401(K) matters with the law firm of Yoder &**
17 **Langford, P.C., in the amount of \$10,000.00 for the period of October 1, 2016**
18 **through September 30, 2017.**

19 **BE IT FINALLY RESOLVED that the funding for the Attorney Contract shall be provided from the**
20 **401(K) Trustee Budget and that the Chairman of the Nation is authorized to**
21 **execute the Attorney Contract in substantially the form attached.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
23 **day of FEBRUARY, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR;**
24 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
25 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
26 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
28 **June 18, 1934 (48 Stat.984).**
