

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting February 28, 2017 Special Session to Consider Judicial Appointments to the
Tohono O'odham Judicial Court)**

LEGISLATIVE ORDER NO. 17-065

1 **WHEREAS,** the Legislative Council is vested with the power "to establish rules and
2 procedures to regulate all meetings of the Tohono O'odham Council, standing
3 committees, boards and special committees." (Constitution of the Tohono
4 O'odham Nation, Article VI, Section 1(a)); and

5 **WHEREAS,** the Legislative Rules of the Tohono O'odham Legislative Council vests the Council
6 with the authority to "by majority vote, call for a special session" (Legislative
7 Rules of the Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and

8 **WHEREAS,** the Judiciary Committee has requested a special session on February 28, 2017 to
9 consider judicial appointments to the Tohono O'odham Judicial Court.

10 **NOW, THEREFORE, BE IT ORDERED** by the Tohono O'odham Legislative Council that it sets a
11 special session on February 28, 2017 to consider judicial appointments to the
12 Tohono O'odham Judicial Court.

13 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 10TH day of
14 FEBRUARY, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-
15 AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by
16 Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the
17 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
18 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
19 18, 1934 (48 Stat.984).
