| 9 | WHEREAS, | 6 Tohono O'odham Code, Chapter 1 - Courts and Procedures, provides in part |
| 10 | | that trial court judges shall serve six-year terms, provided that an appointment |
| 11 | | to fill a vacancy occurring before the expiration of a term shall be made only for |
| 12 | | the remaining balance of that term (Section 1103(A)); and |
| 13 | WHEREAS, | the Judiciary Committee, having legislative oversight of matters pertaining to |
| 14 | | the Tohono O'odham Judicial Court, has reviewed Mr. Harvey's application and |
| 15 | | background information, and has interviewed Mr. Harvey; and |
| 16 | WHEREAS, | pursuant to 6 T.O.C. Chapter 1, Section 1103(B), "A judge shall continue in office, |
| 17 | | even if the judge's term has expired, until a successor is appointed and sworn |
| 18 | | in."; and |
| 19 | WHEREAS, | although Donald Harvey's term expired January 31, 2017, he continues in office; |

| 21 | WHEREAS, | the Legislative Council has likewise interviewed Donald Harvey and reviewed his |
| 22 | | application materials and background investigation report. |
